CONTRACTOR SHALL NOT INSTALL OR PUT IN PLACE ANY FORM OF WATER SERVICE BYPASS SYSTEM TO PROVIDE CUSTOMERS WITH TEMPORARY WATER. ANY/ALL TEMPORARY SYSTEMS WILL BE REVIEWED AND PUT IN PLACE BY ONLY DISTRICT OPERATORS OR UNDER THEIR INSPECTION.

THE UNDERSIGNED APPLICANT, OWNER AND EXCAVATOR AGREE JOINTLY AND SEVERALLY TO REIMBURSE THE DISTRICT FOR ANY AND ALL COSTS AND EXPENSES INCURRED BY THE DISTRICT IN CONNECTION WITH THIS PERMIT AND THE WORK CONDUCTED THEREUNDER, INCLUDING BUT NOT LIMITED TO ENFORCING THE REQUIREMENTS OF STATE LAW AND CONDITIONS OF THIS PERMIT. INSPECTIONS MADE TO ASSURE COMPLIANCE THEREWITH, AND MEASURES TAKEN BY THE DISTRICT TO PROTECT THE PUBLIC WHERE THE APPLICANT OWNER OR EXCAVATOR HAS FAILED TO COMPLY THEREWITH INCLUDING POLICE DETAILS AND OTHER REMEDIAL MEASURES DEEMED NECESSARY BY THE DISTRICT.

THE UNDERSIGNED APPLICANT, OWNER AND EXCAVATOR AGREE JOINTLY AND SEVERALLY TO DEFEND, INDEMNIFY, AND HOLD HARMLESS THE DISTRICT AND ALL OF ITS AGENTS AND EMPLOYEES FROM ANY AND ALL LIABILITY, CAUSES OR ACTION, COSTS, AND EXPENSES RESULTING FROM OR ARISING OUT OF ANY INJURY, DEATH, LOSS, OR DAMAGE TO ANY PERSON OR PROPERTY IN CONNECTION WITH ANY WORK CONDUCTED UNDER THIS PERMIT. THIS SHALL NOT BE CONSTRUED AS A LIMITATION OF LIABILITY UNDER THIS PERMIT OR AS OTHERWISE PROVIDED BY LAW.

SPECIAL REQUIREMENTS

- All work is to be performed in accordance with LCWD material specifications and conditions as approved by the Board of Commissioners
 - There shall be a minimum of one (1) year warranty on all work and material
- Backfill compaction: shall be completed in 6" lifts (Final roadway pavement restoration conditions shall be subject to the Town of Lynnfield Roadway and Trench opening permit).
- New service connections must include a sketch of proposed corridor and an as built with appropriate ties to all corporations, curb stop and house entrance points should be provided upon completion of work
